1	All classes are open to all members of the Berkhamsted and District Branch.
2	Entries will be made on the day with the aim of completing staging by 3.15 PM.
3	Plants must be the personal property of the exhibitor.
4	No pot may contain more than one plant, except where plants are grafted.
5	Max. pot sizes given in the Schedule are the maximum allowed and are measured inside the rim to within 3mm (1/8").
6	Plant classification and judging will be in accordance with the BCSS "Handbook of Shows", 10th Edition 2014.
7	All cups and trophies are perpetual challenge awards and remain the property of Berkhamsted and District Branch.
8	Any award may be withheld by the Judge if there is no exhibit of sufficient merit.
9	Liability for loss: All exhibits, personal property etc., are displayed at the owner's risk and no responsibility is accepted for loss or damage by any cause whatsoever, although normal care will be taken.
10	Entry in the show constitutes acceptance of the Rules.
